
Please remember that the Board is here to serve each of you. Feel free to contact your Regional Director or me if you have any questions, on any subject.


If you have already renewed, thank you for your continued commitment. If not, I encourage you to take a few moments to complete your renewal and remain an active part of this incredible organization.

Happy Mardi Gras and Valentines Day to All!!


